New Festival Location. Trussville City Fest will take place at Trussville Civitan Park on The Greenway in Trussville. For GPS purposes, enter 109 Parkway Drive, Trussville, AL 35173

Application fee for food is \$250.00 for multi-item menus; \$200.00 for single-item menu. Electricity is an additional \$75.00. No application will be considered unless completed, signed, and accompanied by the appropriate fee and/or agreement, along with any applicable licenses or permits and proof of insurance. Each vendor is responsible for collecting sales tax and reporting it to the State of Alabama. Vendors are responsible for their own tables, chairs, and shade, etc. **No guarantee made of specific location. A \$25.00 Fee will be charged on all returned checks.**

In consideration of the permission given to this vendor by the Trussville Area Chamber of Commerce (TACC) to use certain specified premises inside the City of Trussville, Alabama, for the purpose of exhibiting and/or selling on the Festival date of this year, this vendor on behalf of him/herself, employees, members, customers, and invitees hereby agrees that the premises are to be used and enjoyed at his/her own risk and agrees to save and hold harmless the TACC and the City of Trussville and any members, employees, agents, and representatives from and against all liabilities, damages, cost fees and expenses or action suits, demands, judgments, and claims of any nature or in any manner arising from, by reason of, or in connection with injury to/or death of persons or damage to property in any manner arising from the use or occupancy of the premises by the vendor or resulting from a condition of the premises or weather-related conditions on move in/setup day or day of Festival. Any video or photographs taken on behalf of TACC of any applicants are the sole property of TACC and may be used to publicize future events. A signed application constitutes a contract to follow all the rules and regulations and is a commitment to participate if accepted. Fees are nonrefundable. Violations of rules and regulations will result in the closing of the vendor's location for the duration of the Festival, without refund, and the applicant may be excluded from future Trussville City Fest events. A current copy of the vendor's permit from his/her local health department must accompany application.
